Individuals can buy and donate high-demand books to the library's collection through the Foundation's Amazon.com Wish List. The Wish List also allows customers to purchase items which they would personally like to see at the library and to shorten waiting lists on

Ready to Read is an Early Literacy Outreach which brings the first essential skills of reading to preschool aged children (ages 3-5). Preschoolers in child care centers or Head Start classrooms are introduced to the joys of reading by an Outreach representative that visits the children for story time. Following the reading session, picture books are given to both the children and their caregivers to extend the benefits of early literacy by incorporating books into everyday life.
